# FOUNDATION AND REGISTRATION

CHRISTIANS FOR PEACE IN AFRICA (CPA) was founded on the 9<sup>th</sup> February 2001, in JOHANNESBURG and registered on the 8<sup>th</sup> of June 2001, as a Non-Governmental Organization (NGO), in PRETORIA, REPUBLIC OF SOUTH AFRICA (RSA). Register number 013-975 NPO.

## AREA OF OPERATION

CHRISTIANS FOR PEACE IN AFRICA (CPA) currently operates in SOUTH AFRICA with the head office located in JOHANNESBURG and branches/ representations all over the African Continent.

- To promote technical and sustainable development assistance in various communities on the continent of Africa.
- To conduct awareness for the prevention of conflicts and establish solidarity on various and sustainable Peace issues in Africa.
