AREA OF OPERATION

CPA membership and partnership has grown from 200 in 2001 to more than 500 in 2002 in Africa as well as around the world.

As in 2001, the organization still facing a big challenge of the none payment of the membership fees and also the lack of funding partners. Many contacts had been done and many proposals for various projects have been sent to, different potential sponsors and funding partners.

CPA ANNUAL GENERAL AND SPECIAL MEETING

The first Annual General Meeting has been held on the 27th of April 2002, to analyze the current situation and the future of CPA
